

The Departments/Corporations who have attended training may launch a demo.tender in the demo website (<http://demoeproc.nic.in>) at an early date for getting acquainted with the e-Procurement process.

3. Other prerequisites required for launching of tender online viz. Applying for Digital Signature Certificates, issuing Office Order defining the roles in e-procurement, standardizing the tender documents may be complied with, without further delay. The Head of Departments are requested to create a link "e-Tender" in the Department website to the Govt. e-Tendering portal viz. <https://pudutenders.gov.in> for quick access. For the ease of Departmental users, formats of Standard bidding document, sample tenders, forms, Circulars, Instructions regarding e-Procurement are given under one roof in the Chief Vigilance Office website under the head "e-Procurement" (<https://cvo.puducherry.gov.in>)
